## Legislative Update

### **Week 10 – April 20, 2012**

The Alabama Legislature completed its 21st legislative day of the 2012 Regular Session Thursday. Among bills considered by the Senate this week, legislators approved a heavily amended bill to tie legislators' compensation to Alabama's median household. Meanwhile, the House focused on legislation including bills to make changes to Alabama's immigration laws and established a uniformed grading system for evaluating school performance. In addition, the House also passed local legislation pertaining to Marshall County, House Bill 660 (H.B. 660). Alabama Public Utilities Alliance (APUA) would like to make you aware of this legislation as it is moving through the legislative process.

H.B. 660 would allow Marshall County fire districts to hold a referendum that would allow a meter fee or service fee on each occupied residence or dwelling. It would provide for the collection and distribution of fees by the water board or authority serving certain areas, public utilities that provide electric service to certain areas or by the revenue commissioner. This new fee would not exceed \$120.00 per year adding up to ten dollars per water or electric customer. These fees would be collected by the utility and distributed to volunteer fire districts. H.B. 660 would also require the volunteer fire department to conduct said referendum. This bill currently awaits consideration before the Senate Committee on Local Legislation and has yet to be scheduled for a hearing or Senate floor action. Please know APUA will continue to monitor H.B. 660 and make you aware should it move forward.

Also this week, two bills APUA has been monitoring went before Governor Bentley for his signature. Senate Bill 272, relating to Alabama's Deferred Compensation Plan for salaried employees of the State of Alabama and House Bill 483, relating to Limestone County TVA payment distributions are both pending the governor's signature as of 4/19.

Relating to secondary metals recyclers; to amend Sections 13A-8-31, 13A-8-35, and 13A-8-37, Code of Alabama 1975; to provide further for the information that must be maintained by the secondary metals recycler; to require notification to law enforcement of the business location and to authorize inspection by law enforcement; to limit certain purchases by a secondary metals recycler; to require purchases of metal be paid by check; to prohibit purchases from persons under a certain age; to provide criminal penalties; and in connection therewith would have as its purpose or effect the requirement of a new or increased expenditure of local funds within the meaning of Amendment 621 of the Constitution of Alabama of 1901, now appearing as Section 111.05 of the Official Recompilation of the Constitution of Alabama of 1901, as amended.

**SB72 Est AL Pub Intrst Energy & Fuel R&D Prg/Approp**

**Status: Second Reading in Senate with Amendment on 2/21**

**By Senator Ward:**

To establish the Alabama Public Interest Energy and Fuel Research and Development Grants Program to provide funding for energy and fuel related public interest energy research and development; to provide that the program is established within the Department of Agriculture and Industries Center for Alternative Fuels; to provide that the Commissioner of Agriculture and Industries shall evaluate and distribute appropriations by the Legislature and other funds allocated for public interest energy and fuel research and development grants based on advisory commission input; to establish the Public Interest Energy and Fuel

Research and Development Grants Fund within the State Treasury; to create the Advisory Commission on Public Interest Energy and Fuel Research and Development Grants; and to make an appropriation from the State General Fund to the fund for the fiscal year ending September 30, 2012, and also for the fiscal year ending September 30, 2013.

##### **SB77 Workers' Comp'; Revise Procedures & Limits**

**SB357 CA: Baldwin Co; Police Jurisdiction; Munic Lines**

**SB527 Create Incentive In-State Production Biodiesel**

**Status: Pending Senate Committee Action**

**By Senator Ward:**

To encourage the use of motor vehicles powered by compressed natural gas, liquefied natural gas, propane, or electricity by a series of incentives for the acquisition of such vehicles and for the installation of refueling equipment; to encourage the in-state production of biodiesel and

cellulosic ethanol; to make legislative findings; to create an incentive for the in-state production of biodiesel and cellulosic ethanol, in an amount to be paid quarterly in a program administered by the Center for Alternative Fuels within the Department of Agriculture and Industries; to provide that such payments would expire after five years; to limit the liability of providers of refueling equipment used by certain alternative fuel vehicles; to amend Section 23-2-150, Code of Alabama 1975, to exempt certain alternative fuel vehicles from the payment of tolls on toll roads, bridges, and tunnels owned by the Alabama Toll Road, Bridge, and Tunnel Authority; to prohibit insurance companies from imposing a surcharge on certain alternative fuel vehicles; to allow the Department of Transportation to designate certain roads as high occupancy vehicle (HOV) lanes, subject to federal limitations; to allow certain alternative fuel and other vehicles to use such lanes; to impose penalties for the unauthorized use of such lanes; to provide that no person would be required to install electric vehicle charging stations; to provide that providers of electric vehicle charging stations would not, merely for that reason, be found to be engaging in the retail sale of electricity; to provide that electric suppliers would be permitted to provide electric vehicle charging stations; to provide that the Public Service Commission would have no jurisdiction over the rates, charges, and fees for electric vehicle charging stations; to allow for an income tax credit of no more than \$1,500 for certain alternative fuel vehicles, limited to 5,000 vehicles per fuel type; to allow an income tax credit for placing in service refueling equipment for certain alternative fuel vehicles, limited to the lower of 30 percent of the cost of such equipment, or dollar limits based on the type of fuel; to provide that, as to both income tax credits, unused credits could be carried forward for five years; to provide that both credits would expire five years after the effective date of the provisions; to allow the various departments, agencies, and centers with administrative duties to promulgate regulations to implement this bill; to provide for the severance of invalid or unconstitutional provisions; to repeal any conflicting laws; and to provide an effective date.

Relating to secondary metals recyclers; to add Section 13A-8-30.1 to the Code of Alabama 1975, to authorize a permitting process for secondary metals recyclers and sellers of nonferrous metals; to provide for criminal penalties for transporting, selling, or purchasing nonferrous metals without a permit; to restrict business hours of secondary metals recyclers and to require certain notification; to amend Section 13A-8-31, Code of Alabama 1975, to require secondary metals recyclers to maintain additional records relating to the purchase of ferrous and nonferrous metals; to limit cash payments for metal property to certain time frames; to amend Section 13A-8-37, Code of Alabama 1975, to provide for criminal penalties for transporting, selling, or purchasing nonferrous metals without a permit; to provide criminal penalties for obtaining a permit for the purpose of transporting or selling stolen nonferrous metals; to provide criminal penalties for cutting, mutilating, defacing, or otherwise injuring real or personal property for the purpose of obtaining nonferrous metals; and in connection therewith would have as its purpose or effect the requirement of a new or increased expenditure of local funds within the meaning of Amendment 621 of the Constitution of Alabama of 1901, now appearing as Section 111.05 of the Official Recompilation of the Constitution of Alabama of 1901, as amended.

**HB93 “One Call Notific Sys”; Excavations; NonParticip**

To amend Section 37-15-5 of the Code of Alabama 1975, relating to the "One-Call Notification System" established for the purpose of receiving notifications by persons conducting excavations or demolitions on or near certain property where underground facilities may be located, to provide that underground facility operators who elect to conduct an in-house program to receive notifications in lieu of participating in the one-call notification system would be responsible under certain conditions for damages to its underground facilities.

To encourage the use of motor vehicles powered by compressed natural gas, liquefied natural gas, propane, or electricity by a series of incentives for the acquisition of such vehicles and for the installation of refueling equipment; to encourage the in-state production of biodiesel and cellulosic ethanol; to make legislative findings; to create an incentive for the in-state production of biodiesel and cellulosic ethanol, in an amount to be paid quarterly in a program administered by the Center for Alternative Fuels within the Department of Agriculture and Industries; to provide that such payments would expire after five years; to limit the liability of providers of refueling equipment used by certain alternative fuel vehicles; to amend Section 23-2-150, Code of Alabama 1975, to exempt certain alternative fuel vehicles from the payment of tolls on toll roads, bridges, and tunnels owned by the Alabama Toll Road, Bridge, and Tunnel Authority; to prohibit insurance companies from imposing a surcharge on certain alternative fuel vehicles; to allow the Department of Transportation to designate certain roads as high occupancy vehicle (HOV) lanes, subject to federal limitations; to allow certain alternative fuel and other vehicles to use such lanes; to impose penalties for the unauthorized use of such lanes; to provide that no person would be required to install electric vehicle charging stations; to provide that providers of electric vehicle charging stations would not, merely for that reason, be found to be engaging in the retail sale of electricity; to provide that electric suppliers would be permitted to provide electric vehicle charging stations; to provide that the Public Service Commission would have no jurisdiction over the rates, charges, and fees for electric vehicle charging stations; to allow for an income tax credit of no more than \$1,500 for certain alternative fuel vehicles, limited to 5,000 vehicles per fuel type; to allow an income tax credit for placing in service refueling equipment for certain alternative fuel vehicles, limited to the lower of 30 percent of the cost of such equipment, or dollar limits based on the type of fuel; to provide that, as to both income tax credits, unused credits could be carried forward for five years; to provide that both credits would expire five years after the effective date of the provisions; to allow the various departments, agencies, and centers with administrative duties to promulgate regulations to implement this bill; to provide for the severance of invalid or unconstitutional provisions; to repeal any conflicting laws; and to provide an effective date.
